- 1. Call to Order
 - a. Meeting was called to order at 7: 30 PM by Victor Martin
 - i. Attendance: Victor Martin, Bryan Welch, Nick Swiatkowski, Natalia Silva, Marty Aubrie, Lyndi Nickerson, Jose Silva, Ami Bush
 - ii. Crystal Hunter was not in attendance
- 2. Officer Updates: N/A
- 3. New Business: HOA Management Company
 - a. Board reviewed and voted on three Management Company Bids: 1) Byers and Harvey 2) Top Flight 3) SW Community Management
 - i. Nicholas ensured all board members were aware that he and Bryan own SW Community Management
 - ii. Nicholas reviewed conflict of interest definitions and state laws pertaining to non-profits to ensure we complied, highlighting that SW was the cheapest, shortest contract out of the three
 - iii. Nick and Bryan recused themselves from voting for a management company to resolve the conflict
 - iv. Victor Martin motioned to vote on a management company
 - v. Jose Silva seconded the motion
